CONDITIONS OF USE

1. The Lethbridge Sport Council shall not be held liable for injury or accident resulting from the use or misuse of any equipment. It is the responsibility of the renter to use the equipment in the intended manner and ensure safety guidelines are followed.
2. The Lethbridge Sport Council requires all renters to have general commercial liability insurance in the amount of two million dollars (\$2,000,000). Please provide a copy of the Certificate of Insurance prior to the rental pick up date.
3. No post-dated cheques will be accepted as payment for a rental. Credit card or cheque payments are accepted.
4. All equipment rented will be inspected upon return for cleanliness and damages. Concerns will be communicated at this time and the appropriate fees charged.
5. Replacement of lost or damaged equipment belonging to the Lethbridge Sport Council will be invoiced to the renter at full replacement cost.
6. A down payment of \$100.00 or 25% of the total equipment rental fee (whichever is greater shall apply) must be paid to reserve the booking. This fee is non-refundable.
7. The rental fee must be paid in full prior to picking up the equipment for usage.
8. The Lethbridge Sport Council reserves the right to require a damage deposit for rental.
9. The renter will use the equipment only at the location and on the days defined in this Agreement.
10. The renter will provide the necessary manpower to load and unload all equipment at the time of pick up and return.
11. The Lethbridge Sport Council reserves the right to refuse a rental.

By signing this agreement, the renter acknowledges and accepts all the conditions and requirements specified in this agreement and Conditions of Use and confirms that the information given above is accurate and complete; and agrees to report any changes to that information to the Lethbridge Sport Council immediately.
